Thom D. Balmer, Ph.D, LPC, LMFT



Speaker: Dr. Thom D. Balmer has been a licensed professional counselor and licensed marital and family therapist since 1984 and 1994 respectively. He has practiced in Kentucky, Texas, and Oklahoma as an inpatient, residential, and outpatient counselor and director. He is a faculty member with the Department of Human Relations at the University of Oklahoma. He was the first Chair of the Oklahoma Board of Behavioral Health Licensure in 2013 and 2014, and is currently a Board member representing LMFT's. Thom loves to learn and loves to teach. He believes being healthy in physical, emotional, relational, spiritual, economic, and nutrition ways is paramount for providers.

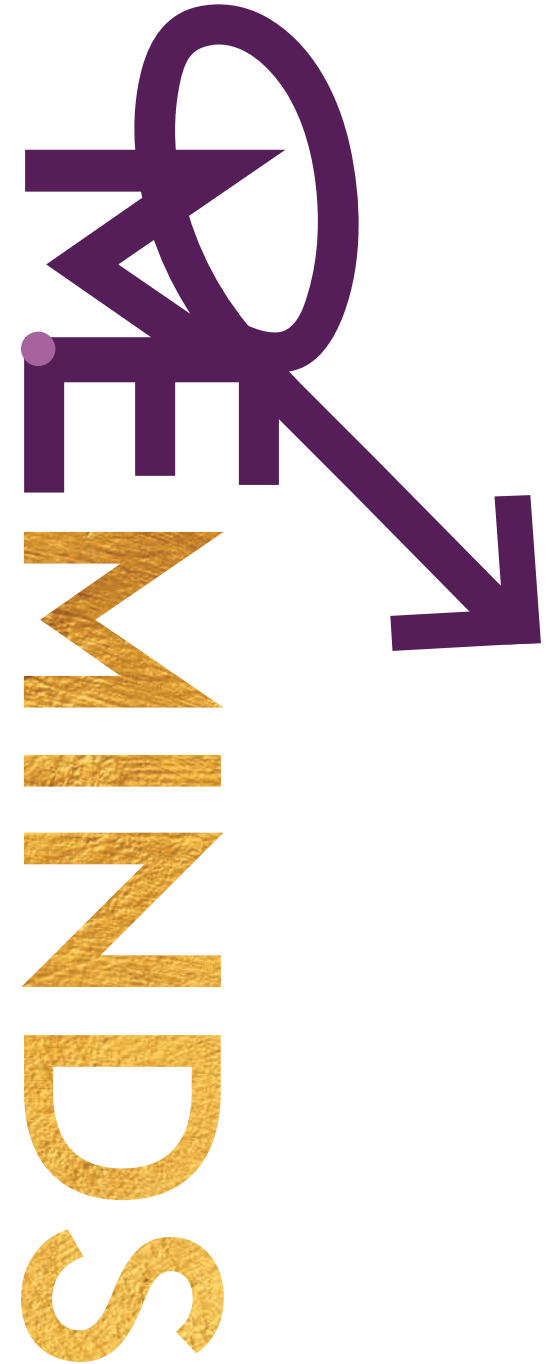
